Internal Quality Assurance Cell (IQAC)

The establishment of the Internal Quality Assurance Cell (IQAC) within higher education institutions has become a crucial requirement to ensure ongoing quality maintenance. Its primary functions include performance evaluation, assessment, accreditation, and enhancing overall quality standards.

The key objective of the IQAC is to devise a systematic approach aimed at fostering conscious, consistent, and transformative enhancements in the overall performance of the institution.

Given that quality enhancement is an ongoing endeavour, the IQAC at Siddharth University, Kapilvastu, Siddharth Nagar shall play a pivotal role within the institution's quality assurance framework. It will actively strive towards both enhancing and sustaining quality standards.

To cultivate a culture of quality as the foremost priority at Siddharth University, Kapilvastu, the IQAC shall institutionalize and internalize all initiatives aimed at enhancing and sustaining quality. This concerted effort, supported both internally and externally, aligns with the University's vision and mission, guiding it towards realizing its goals.

OBJECTIVES:

- Establishing a mechanism to encourage deliberate, regular, and proactive action plans for enhancing both academic and administrative performance within the institution.
- Fostering University quality enhancement and sustainability by ingraining a culture of quality and institutionalizing exemplary practices.

STRATEGIES:

The IQAC at SUK will develop mechanisms and procedures for:

- Ensuring timely, efficient, and continuous progress in the performance of academic, administrative, and financial units.
- Adopting pertinent and high-quality academic and research programs.
- Guaranteeing fair access and affordability of academic programs for all segments of society.
- Optimizing and incorporating modern teaching and learning methodologies.

- Ensuring robust assessment and evaluation processes.
- Properly allocating, ensuring adequacy, and maintaining support structures and services.
- Facilitating the dissemination of research findings and fostering networking with institutions both nationally and internationally.

FUNCTIONS:

Here are the important functions of IQAC, SUK:

- Developing and applying quality benchmarks.
- Establishing parameters for various academic and administrative activities.
- Fostering a learner-centric environment conducive to quality education and faculty development, enabling them to embrace necessary knowledge and technology for interactive teaching and learning.
- Collecting and analysing feedback from all stakeholders regarding University processes related to quality.
- Disseminating information on various quality parameters to stakeholders.
- Organizing intra- and inter-University workshops and seminars on quality-related topics and promoting quality circles.
- Documenting various programs and activities aimed at improving quality.
- Serving as the central agency within the University for coordinating quality-related activities, including adopting and disseminating best practices.
- Developing, supporting the process of recruitment, annual appraisal and career advancement of the academic and non-academic staff of the University.
- Developing and maintaining an University database to enhance and maintain University quality.
- Conducting periodic academic and administrative audits, followed by necessary actions.
- Preparing and submitting the Annual Quality Assurance Report (AQAR) in accordance with NAAC guidelines and parameters.

COMPOSITION OF THE IQAC:

The IQAC at SUK will be constituted with the Honourable Vice-Chancellor (Head of the Institution) as the chairperson. It will include heads of key academic and administrative units, along with several teachers, distinguished

educationists, and representatives from local management and stakeholders as members.

The composition of the IQAC shall be as follows:

- 1. Chairperson: Honourable Vice-Chancellor of the SUK.
- 2. Teachers to represent all levels (Assistant Professor, Associate Professor and Professor) (Three to eight)
- 3. The senior administrative officer(s).
- 4. One nominee each from the Local Society/Trust, Students and Alumni
- 5. One nominee each from the Employer/Industrialists/Stakeholders
- 6. One of the senior teachers as the Director of the IQAC.
- 7. Two teachers as the Assistant Director of the IQAC.
- The composition of the IQAC will be tailored to fit the size and complexity of the University, with the representation of teachers and others adjusted accordingly (The Director of the IQAC shall notify the Chairperson of any such requirements).
- Nominated members will serve for a term of three years.
- The IQAC is required to convene once every quarter.
- The quorum for meetings will be two-thirds of the total number of members.
- Agenda, minutes, and action taken reports will be documented and maintained electronically in a retrievable format.
- The invited members can be included in IQAC on the recommendation of Director IQAC and approval of chairperson.

ROLE OF THE COORDINATOR/DIRECTOR OF THE IQAC:

- The Director IQAC holds a pivotal role in ensuring the efficient functioning of all members.
- Administrative support, including secretarial assistance, will be provided to the IQAC Director by the administration.
- Proficiency in computer skills and data management is essential for the Director of IQAC to effectively carry out their responsibilities.

OPERATIONAL FEATURES OF THE IQAC:

- The IQAC shall be responsible to the Vice Chancellor of the University with respect to the quality system, procedures and initiatives of the University.
- The IQAC shall ensure that all activities within the institution for higher education are carried out efficiently and effectively.
- To achieve this, the IQAC will establish procedures and methods to gather data and information on various aspects of University functioning.
- The IQAC may leverage support from existing units and mechanisms that contribute to the functions.
- The IQAC may also create an exclusive section on its University website to store documents related to NAAC, Peer Team Reports, SSR, Data Templates, AQAR, and Certificate of Accreditation.
- The IQAC shall coordinate the ranking, rating and the quality certification of the department/Sections/University, by various agencies.
- The IQAC shall provide advisory support related to quality systems and procedure to the administration.

The teacher shall be assessed for the remaining period of duration and the same shall be extrapolated for the entire period of assessment to arrive at the grading of the teacher. The teacher on such leaves or deputation as mentioned above shall not be put to any disadvantage for promotion under CAS due to his/her absence from his/her teaching responsibilities subject to the condition that such leave/deputation was undertaken with the prior approval of the competent authority following all procedures laid down in these regulations and as per the acts, statutes and ordinances of the parent institution.
