(b) may advise the Executive Council on all academic matters including matters relating to examination conducted by the University; (c) shall have such power and duties as may be conferred or imposed upon it by the Statutes. **The Dean of Students Welfare, Controller of Examination, Registrar and Librarian shall be *ex-officio* members.**

**The member of the Academic Council, other than *Ex-officio* members, shall hold office for a term of three years from the date of Notification issued in his/her regard.**
